Visitors to Salvador will be interested in a letter dated

22 November 2005 from Salvador, reference Formalities.

The changes in access and procedure below are courtesy of Kent Nyberg,
a Swedish lone sailor who has cruised for some years and wrote to congratulate
the author for the South Atlantic Circuit.

It appears that just like Cape Town, a wall, or fence, has been built around the Port of Salvador.

"The Policia Federal Porto are now inside the port. Continue along the road indicated, but you should turn left into the port about 100m from the large building mentioned.

You will need to walk back about the same distance to the Policia Federal Porto entrance.

Visit the Vigilancia Sanitiaria for a 'certificado de livre practica'

as you walk back to the entrance of the port.

You should see the notice within the port buildings.

The Customs entrance is still on the outside of the port about 200m from the ferry dock.

The Capitania dos Portos needs a copy of all of the documents you have.

You can make copies at the Post Office opposite the Capitania dos Portos offices.
