# NOTICE OF RACE

#### 1 RULES

- 1.1 The regatta will be governed by the rules as defined in *The Racing Rules of* Sailing 2017 – 2020 as amended by the prescriptions of the RYA.
- 1.2 IRC 2017 Rules Parts A, B & C and ISAF Special Regulations will apply.

## 2 ADVERTISING

Boats may be required to display advertising chosen and supplied by the organizing authority.

# **3 ELIGIBILITY AND ENTRY**

- 3.1 The regatta is open to all yachts of the single Service Sailing Associations, Service Establishments and associated sailing associations and yacht clubs, together with privately owned yachts crewed by retired service personnel, their immediate families or civilians currently employed in the Armed Forces of the Crown.
- 3.2 Eligible boats may enter by completing the attached form and sending it, together with the required fee to

by 31<sup>st</sup> May 2017.

3.3 Late entries will be accepted at the discretion of the Race Committee.

#### 4 FEES

4.1 Fees are detailed on the entry form.

#### 5 SCHEDULE

- 5.1 Registration will take place on 19 June 2017 from 0900 to 1130.
- 5.2 Racing will take place 19-24 Jun.

5.3 The scheduled time of the warning signal for the first offshore race is 1555. The warning signal on subsequent days shall be made at 0855 unless otherwise advised by the Race Committee.

#### 6 MEASUREMENTS

- 6.1 Each boat racing IRC shall produce a valid rating certificate.
- 6.2 The handicap system and TCF for yachts in the cruising class will be determined by the SOR race committee

## 7 SAILING INSTRUCTIONS

The sailing instructions will be available after 1200 on 05 June on the RNSA website and will be issued on registration at the Race Office on 19 June 17.

#### 8 VENUE

Registration will take place at JSASTC, Gosport. Racing will take place in the Solent and English Channel.

#### 9 THE COURSES

The courses to be sailed will be identified using fixed navigation marks and Solent racing marks as appropriate.

#### 10 PENALTY SYSTEM

- 10.1 For the all classes rule 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.
- 10.2 Decisions of the protest committee will be final as provided in rule 70.5.

# 11 SCORING

- 11.1 2 Offshore races are required to be completed to constitute the offshore series.
- 11.2 2 Inshore races are required to be completed to constitute the Inshore series.
- 11.3 All races sailed in each series will count for the respective series.

## 12 HAUL-OUT RESTRICTIONS

Keelboats shall not be hauled out during the regatta except with and according to the terms of prior written permission of the race committee.

#### 13 DIVING EQUIPMENT AND PLASTIC POOLS

Underwater breathing apparatus and plastic pools or their equivalent shall not be used around keelboats after 0800 on the 19<sup>th</sup> June and the end of the regatta.

## 14 RADIO COMMUNICATION

Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

## 15 PRIZES

Prizes will be given as detailed in the SIs.

# 16 DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

## **17 INSURANCE**

Each participating boat excluding the JSASTC owned Vic 34s shall be insured with valid third-party liability insurance with a minimum cover of  $\pounds 2,000,000$  per event or the equivalent.

8. All non-service entrants should carry reasonable 3<sup>rd</sup> Party liability insurance of not less than £2M.
