# **Notice of Race**

# Salcombe race 1 Sep 2018

## 1 RULES

- **1.1** The race will be governed by the rules as defined in *The Racing Rules of Sailing*.
- **1.2** Racing rule(s) 33, 52, 61.3, 62.2 and A4 will be changed. The changes will appear in full in the sailing instructions. The sailing instructions may also change other racing rules.
- **1.3** The World Sailing Offshore Special Regulations **(OSR) Category 3 & 4** shall apply depending on class entered. (www.sailing.org/specialregs).
- **1.4** These race will also contribute towards the 2018 Ullman inshore series administered by the PPSA.
- **1.5** Where yachts are racing within the boundaries of a port, they shall comply with such regulations that may be in force within that port. In particular, regulations regarding interference with the safe navigation of large vessels must be strictly observed. Any breach of such regulations may result in the yacht concerned being disqualified from the race in which she was sailing at the time or, if the breach is considered serious, such other races as the Race Committee may decide. Attention is drawn to the Dockyard Port of Plymouth Order (DPPO) 1999 and to Plymouth Local Notice to Mariners. ## 2 ELIGIBILITY AND ENTRY

- 2.1 IRC Division For monohull boats holding a valid International Rating Certificate (IRC) issued by the RORC a copy of which shall be attached to the entry form. OSR CAT 3 additioanly a liferaft in accordance with 4.20.1.
- 2.2 PORT HANDICAP DIVISION for monohull boats rated under the PORT HANDICAP DIVISION Scheme as administered by the Port of Plymouth Sailing Association. OSR CAT 3 additioanlly a liferaft in accordance with 4.20.1
- 2.3 **PORT HANDICAP DIVISION Two handed Division** for monohull boats rated under the PORT HANDICAP DIVISION Scheme as administered by the Port of

Plymouth Sailing Association and racing with only two people onboard. OSR CAT 3 additioanly a liferaft in accordance with 4.20.1

- 2.4.1 **PORT HANDICAP DIVISION Category 4 with prescriptions –** for monohull boats rated under the PORT HANDICAP DIVISION Scheme as administered by the Port of Plymouth Sailing Association. **OSR CAT 4 with prescriptions IAW Annex A.**
- 2.4.2 This class is designed solely for yachts that are unable, by their design, to meet the requirements of OSR Cat 3 and will be subject to strict weather limitations. As such in the event of anything other than fair weather this class will be cancelled.
- 2.5 Full details of class eligibility at annex A.
- **2.5** Eligible boats may enter by completing the attached form and sending it, together with the required fee to:

2.6 Entries will be accepted up **until 36 hours** before the start of the race. Entries submitted **after 2200A 30 August 2018 may** be accepted at the discretion of the race officer.

The will be a reception and prize giving event on the Saturday evening after the race, further details will be promulgated along with the SIs.

### 5 SAILING INSTRUCTIONS

- **5.1** The sailing instructions will be available no less than 72 hours before the start of each event. They will be posted on the RNSA website under the 'Branches section' (<u>www.rnsa.org.uk</u>). They will also be emailed directly to the email address given on the entry form.
- **5.2** Last minute changes to the sailing instructions will be promulgated by VHF (Channel 72) immediately prior to the warning signal for the race, in which case flag L will be flown from the starting hut.

#### 6 THE COURSES

- 6.1 The courses will be described in the sailing instructions issued for the race.
- **6.2** The race Plymouth to Salcobme race will be started, and signals made ashore will be displayed, from the Plym yacht club start line located at the end of Milbay Breakwater. This will also be the finish line for the return race.
- **6.3** The Plymouth to Slacombe race only, will (weather dependant) utilise L4 buoy (Approx position 50°15.03N 004°13.01W) as a rounding mark.
- 6.4 The Finish line for Saturday and start line for Sunday will be in Salcombe Range; utilising a yacht anchored in Starehole bay, weather permitting.

#### 7 BERTHING

The OA will make the Salcombe harbour authority aware of the event and the number of yachts expected for berthing. Finding a berth / mooring is each yacht's responsibility, but it is expected yachts will be directed towards the visitors pointoon in the bag.

#### 8 RADIO COMMUNICATION

Yachts shall be equipped with a working VHF capable, as a minimum, of receiving and transmitting on Channels 6, 16, 37(M1) and 72. VHF 72 will be the primary VHF channel.

#### 9 PRIZES

Prizes will be awarded at the RNSA prize giving for each Division/Class in proportion to the number of starters as follows:

1-5 entries1st6-10 entries1st, 2nd.11+ entries1st, 2nd, 3rd.

#### 10 RISK STATEMENT

Rule 4 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone." Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

**a.** They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;

- **b.** They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;
- **c.** They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- **d.** Their boat is in good order, equipped to sail in the event and they are fit to participate;
- e. The provision of a race management team, other officials and volunteers by the event organiser does not relieve them of their own responsibilities;
- **f.** The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances;
- **g.** It is their responsibility to familiarise themselves with any risks specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event and to attend any safety briefing held for the event.
- h. They are responsible for ensuring that their boat is equipped and seaworthy so as to be able to face extremes of weather; that there is a crew sufficient in number, experience and fitness to withstand such weather; and that the safety equipment is properly maintained, stowed and in date and is familiar to the crew.

#### 11 INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of  $\pounds$ 3,000,000 per incident or the equivalent.
